

Rusk County Electric Cooperative, Inc.

Education Scholarship Fund

for 2026 Scholarships

Rusk County Electric Cooperative (RCEC) has a scholarship fund to assist its members' graduating high school seniors who desire to further their education. Scholarships are awarded to students based on several criteria: demonstrated civic responsibility, scholastic achievement, and financial need.

QUALIFICATIONS

High school seniors and non-traditional students (those attending private, parochial, or home schools) are eligible to apply.

The applicant's immediate family must be active members of RCEC, and the applicant's permanent residence must be within the RCEC service area.

APPLICATION

1. The applicant must personally complete the scholarship application, and
2. Must be accompanied by the School Certification form & High School Transcript.
3. Two letters of recommendation are required from a teacher, principal, or counselor from the high school the applicant is attending. They cannot be from a relative. If the student is homeschooled, the letters of recommendation may be signed by individuals in the student's community.

ADMINISTERING OF FUNDS

1. All scholarship funds will be paid directly to the educational institution of your choice (university, junior college, technical or vocational school).
2. The recipient must enroll in classes and contact RCEC for payment of the scholarship within one year after high school graduation.
3. A minimum of twelve semester hours as a full-time student is required, or full-time enrollment in a technical or vocational school is required.
4. If the recipient does not attend school and contact RCEC for payment within one year following graduation, the scholarship reverts to the scholarship fund.
5. The scholarship will be paid after sending proof of enrollment in the required semester hours to RCEC's Scholarship Committee.
6. It is the recipient's responsibility to contact RCEC for payment of the scholarship.

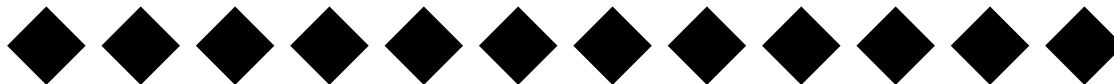
